Provided that articles meet the preliminary evaluation requirements, they are sent to three anonymous referees. Names of both the referees and the author are kept confidential in this process. In line with the referee reports, editorial board decides whether to publish the article or not. Scientific responsibility for the articles belongs to the authors themselves. Published articles could be cited in other publications provided that full reference is given. After publication, the copyrights of the articles belong to the Business, Economics and Management Perspectives. No copyright fee is paid to the authors. Articles published in this journal cannot be published elsewhere and/or copied without the consent of the Business, Economics and Management Perspectives.
